Today, President-Elect Biden and Vice President-Elect Harris will be inaugurated, marking the commencement of their terms as President and Vice-President. FEDERAL

1. President-Elect Biden is expected to outline a \$1.9 trillion spending package to combat the pandemic and its effects on the economy, with an initial focus on large-scale expansions of the nation's vaccination program and virus-testing capacity. [The New York Times reports.](#)

2. The Shuttered Venue Operators Grant (Save Our Stages Act) passed as part of the third stimulus package. It includes \$15 billion for grants of up to \$10 million to qualified live venue operators and promoters, performing arts organizations, theatrical producers, talent representatives, movie theater operators, and nonprofit museums that have auditoriums. The law requires the U.S. Small Business Administration to issue program guidelines by February 10, 2021. Until then, the National Independent Venue Association has posted [a helpful plain language FAQ](#).

3. The Small Business Administration released additional PPP guidance interpreting provisions of the new COVID relief law:

4. U.S. Department of Labor Suspends Enforcement on Race and Sex Stereotyping Executive Order. The Office of Federal Contract Compliance Programs, under the U.S. Department of Labor, [issued a notice that it will suspend the enforcement of and the collection of information](#) under the President's [Executive Order 13950 – Combatting Race and Sex Stereotyping](#). The U.S. District Court for the Northern District of California issued a [preliminary injunction that prohibits the federal agency from implementing, enforcing, or effectuating Section 4](#) of the executive order "in any manner against any recipient of federal funding." The preliminary injunction was effective immediately.

NEW YORK STATE

1. New York Governor Andrew Cuomo announced a [program of pop-up arts performances across the state](#), featuring performers from the worlds of dance, music, theater, film, and comedy.
2. President-Elect Joe Biden's transition team has committed to a policy change that will give New York about \$2 billion to reimburse State and City governments for COVID-19 expenses, [the New York Post reported](#).
3. Sign on in support of [A11154 \(Paulin\), a bill to ensure the constitutionally protected personal and private data such as names, addresses, and telephone numbers of those who contribute to 501\(c\)\(3\) nonprofits are protected from unnecessary disclosure](#), and remove the double-reporting obligation the Department of State of organizations registered with the Charities Bureau.

NEW YORK CITY

1. Learn more about [Open Culture in NYC](#):
 - a. Open Culture permits will be available for March 1 - October 31, 2021 via a streamlined application process with up to \$20 fee.
 - b. [Existing Open Streets sites](#) are eligible to host arts events through the Open Culture program.
 - c. The application will launch in early February.
 - d. Artists can charge admission for activities held outdoors as part of Open Culture.
2. Sign on to a letter created by the League of Independent Theater to be submitted to State Senator Serrano to ask for a hearing on the reopening process moving forward for arts and culture in 2021.

3. [NYC COVID Rent Relief Extension Program](#) is accepting applications through February 1, 2021. Disabled New Yorkers can apply to [Disability Rent Increase Exemption \(DRIE\) Program](#).
4. Use [Dance Rising's advocacy template](#) to introduce yourself to your elected officials and advocate for the Dance sector.
5. Dance/NYC has been working with Nonprofit New York and coalition partners advocating to raise the financial threshold as a part of the A Place at the Table campaign. The campaign seeks to reduce barriers for nonprofits to engage in legislative advocacy. We need your support! 6. COVID-19 Updates
 - a. The ["Am I Eligible" web application](#) helps New Yorkers determine if they are eligible to get the vaccine. *The Gothamist* published a [Guide to Getting Vaccinated](#). However, Mayor De Blasio expects NYC to run out of COVID-19 vaccine supply sometime this week, [AM NY reports](#).
 - b. The statewide positivity rate was 6.14%.

- c. State [COVID zone restrictions](#) remain in effect in certain parts of the city. To find out where the zones are and to see what restrictions apply to each zone, please visit www.nyc.gov/covidzone

For the ongoing [Coronavirus Dance Impact Study](#), Dance/NYC is tracking studio & company temporary and permanent closures to gain a better understanding of the financial impact the pandemic is taking on the dance sector. This data will be used to better document this historic time and to be able to advocate for aid to policymakers. You do not need to be in charge of the organization to send a notification as Dance/NYC works to compile a list of closures.
