

## Coronavirus Dance Relief Fund: New York State Edition Tier I: Individual Dance Makers Application Guide

### Application Guide Introduction:

- This application guide includes all possible questions that appear in the application. You may not have to answer every question as you are completing your application.
- Dance/NYC is looking for clear, concise answers to application questions. Suggested word counts are provided on some fields as recommendations, however applicants can write as little or as much as they need in order to answer the questions as best they can. Applicants will not be penalized for the length of their submission as long as they answer the questions fully.
- Grammar is not taken into consideration in scoring by the review panel, unless the grammar quality disturbs overall comprehension of the application. Scores are not connected to whether or not an applicant has strong written English skills.
- Dance/NYC discourages applicants from trying to answer in a way that is based on what they think reviewers might want to hear. Please be honest in your responses.

#### Instructions:

Dance/NYC invites individual dance makers residing in New York State who are experiencing financial losses due to the spread of COVID-19 to submit proposals for financial relief support. Each individual dance maker selected as a grantee will receive a relief support grant of \$1,500 for FY22 expenses.

Before completing the application form, interested individual dance makers are asked to first complete a series of questions to determine baseline eligibility for the grant program. If eligible, applicants will be prompted to complete the application. The application consists of six (6) sections in which applicants will be asked to provide contact, banking, and demographic information, and also respond to questions related to how the COVID-19 pandemic has impacted their artistic work, income, and personal life over time. All questions are required unless otherwise indicated.

Dance/NYC estimates applicants may need approximately 2-3 hours to complete their application if they have the required information readily available. Applicants may save draft content by scrolling to the bottom of the application form and clicking "Save Draft," and may return to finish the form at any time prior to the deadline. Complete applications, including supplementary materials, must be submitted online by April 20, 2022, 6:00 p.m. EST, though the application may be closed sooner if 1,500 applications are received prior to this date. Incomplete applications, hard copy submissions, and applications received after the April 20 deadline will not be considered. Due to the anticipated volume of applications, Dance/NYC will not be able to follow up on incomplete applications.
