### Donor Advised Fund

A donor-advised fund (DAF) allows you to have the flexibility to tailor your philanthropic giving in easy, cost-effective ways. You can designate funds to a specific grantmaking fund, make an unrestricted annual gift or recommend a donation for a special appeal.

Some benefits of contributing through a DAF include:

- flexible funding options
- tax advantages
- typically requires no minimum distribution
- anonymous granting
- investment options

#### HOW TO RECOMMEND A GIFT TO DANCE/NYC:

Step 1: Request a grant distribution through your DAF sponsor.

Be sure to use Dance Service New York City, Inc's EIN # 46-0830780.

Indicate whether your gift is unrestricted or designated to a specific cause i.e. the program, appeal, or general operating. You can also designate Dance Service New York City, Inc. as a beneficiary for your DAF.
