- Manage Individual Giving and Major Gifts programs from prospecting to stewardship
- Write, research, and manage government and foundation grants
- Work with the Board's Financial Committee on annual development plans for long-term growth, budgetary strategy, and engage the entire board in fundraising efforts. Work with ED and marketing staff to create annual giving campaigns
- Plan fundraising events alongside admin team including annual Benefit Dinners/Galas
- Cultivate donor relationships through public outreach, segmented communications, and individual conversations
- Database and contact management

- Understand the power of storytelling to effectively persuade and enlist potential donors and partners to join PCDC
- Have experience cultivating and securing major gifts through prospecting, research, proposal development, relationship development, and face-to-face solicitation
