Dear Dance Community,

Today, March 11, 2021, marks the one-year anniversary of Dance/NYC's public acknowledgement of COVID-19 in New York City and the beginning of what has been an unprecedented year of service and urgent response to a sector in crisis. As a community we have endured great loss, learned many lessons, and in ceasing "business as usual," the dance sector has been forced to contend with the conditions that have led us individually and collectively to question our survivability and livelihood. We are now tasked with the responsibility to make whatever changes necessary to re-imagine and create a sector that allows each and every one of us to thrive, even during the most challenging times.

In our first [State of the Organization Address](#), released in the Summer of 2020, we made a commitment to address the manifestations of white supremacy in our internal operations, our public programs, and the field. Internally, we responded with an expanded series of infrastructural changes which were already set into motion before the onset of the pandemic. For example, we increased our staff, established higher salary floors, and increased employee benefits to enable greater ease and support to our team as we continue to meet the sector's pressing needs. In terms of programming, we are moving to more coalition-based services, content, and decision-making processes. As you might recall, we took a hiatus from hosting major events for the last quarter of 2020, and instead focused our efforts on advocating on your behalf at the City, State, and Federal levels of government and on building the [2021 Symposium](#).

Led by Research and Advocacy Coordinator, Gregory Youdan, over the last quarter of 2020, we signed on to five legislative letters, offered four testimonies, continued to government bodies, continued to collect data on the enduring impact of COVID19 through our [Coronavirus Dance Impact Study](#), and most recently released the [Reopening Dance in NYC toolkit](#). Led by Manager of Justice, Equity, and Inclusion Initiatives, Candace Thompson-Zachery, we worked with a [Symposium Programming Committee](#) of dance workers, curators, and organizers to create the new four-day digital event. To respond to the changing financial realities of the sector, we established new ticketing tiers that better reflect people's financial possibilities and will soon announce ways members of the community can engage for free.

In an effort to continue to serve you transparently, here is what you can expect from us over the coming weeks:

From today through March 20, 2021, the entire Dance/NYC team will focus our efforts on producing the [2021 Symposium](#). During this time, all other Dance/NYC programs, communications, and/or events will be on pause, including our weekly field-wide calls and advocacy alerts. We are very excited to share this special time with you online. You can learn more about the programming and features of this year's Symposium by visiting [Dance.NYC](#).

To continue our practice of rest and restoration, the Dance/NYC offices will be closed directly following the Symposium from Monday, March 22 through Sunday, March 28 for spring break. Upon our return, we will focus exclusively on internal intention setting from Monday, March 29 through Sunday, April 4. During this period, our remote office will be closed for external activity which includes, but is not limited to, all public-facing communications: e-newsletter, e-newsletter ads, website ads, e-blasts, social media, advocacy alerts, field-wide calls, and email. To help you continue to access important resources, you can find the answers to your most frequently asked questions here including details on where you can get timely information about the field while we are away.

We will resume our outward facing services to the field and communications with you on Monday, April 5, 2021. We invite you to join us for the month's events, including the return of our [Field-wide calls](#) on Thursday, April 8 at 4:00 p.m. and the [Arts and Cultural Workers for the New York Health Act Town Hall](#) on Friday, April 9, 2021, at 6:00 p.m. Visit [Dance.NYC](#) for upcoming event announcements and registration information.
