

Teaching Artists needed for K-12 grades and senior centers. The right candidate will have experience or the desire to work in a public school or community center setting, be highly organized, and have strong class management skills. This is an exciting and rewarding position for educators who are interested in using dance as a vehicle for transformation, building inclusive, responsive, and developmentally appropriate lessons. Dancewave's priority is to actively uphold anti-oppressive and culturally responsive standards in teaching student-centered approaches to build community in the classroom.
