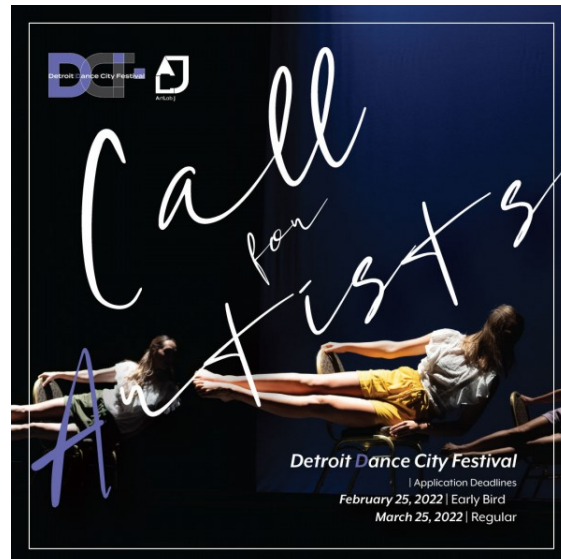

*National Opportunities:

One Choreographer will be selected for the opportunity to perform at the 2023 Dumbo Dance Festival in New York, NY.

One Choreographer will be selected for the opportunity to return as a guest performer at the 2023 Detroit Dance City Festival.

*International Opportunity:

One Choreographer will be selected for the opportunity to perform at the 2023 New Dance Festival in Daejeon, South Korea.
