# Take the \*NEW\* Coronavirus Dance Impact Survey today!

## FEDERAL

- 1. PPP Loan Forgiveness Resources:
- a. Fiscal Management Associates <u>PPP Toolbox</u> has a number of different resources including <u>guidance on restricted funding</u>, <u>tools to calculate your FTEs</u>, regular <u>live clinics</u> and a dedicated email helpdesk: <u>FMACARES@fmaonline.net</u>.
- b. FMA's quick  $\underline{\text{Forgiveness Check-In}}$  to share how you're approaching forgiveness.
- c. FMA launched the <u>PPP Forgiveness Racial Equity Initiative</u> prioritizing customized advisory support for organizations led by BIPOC-identified individuals as well as organizations where BIPOC-identified individuals are managing the PPP process.
- 2. Help support the <u>Heroes 2</u> act on social media using this <u>Heroes Act Social</u>
  <u>Media Kit.</u> Check out this <u>one-page summary</u> of the Revised House Heroes
  Act.
- 3. Sign the <u>Arts Education Pledge</u>. Join hundreds of supporters in committing to advocacy for arts education in their local schools and community.
- 4. Federal Judge blocks <u>U.S. Citizenship and Immigration Services (USCIS) fee increases</u>. These increases would have raised the price to become a US citizen and visa fees for immigrants.
- 5. The Supreme Court ruled the Census can be cut short, halting the 2020 Census count ahead of schedule, effectively shutting it down. For more information, see here. Tomorrow is now the last day to take the census by

- 6. Dance/USA Updates:

#### NEW YORK STATE

- Gov. Andrew M. Cuomo moves forward with new restrictions on gatherings at synagogues and other houses of worship. For more information, see the NY Times article.
- 2. Governor Andrew Cuomo issued a new executive order extending the expiration date of vehicle registrations and vehicle inspections to November 3. This new order states that this will not be extended again. For more information, see Executive Order.
- 3. Ohio, Michigan and Virginia have been added to New York's COVID Travel Advisory. See the full list <u>here</u>.

### **NEW YORK CITY**

- 1. Testify at <u>Committee on Cultural Affairs, Libraries and International Intergroup Relations</u> on Tuesday, October 20, 2020. It is held at 10:00 a.m. virtually via zoom, regarding Black Lives Matter, anti-racism, structural racism and the arts. Register to testify <u>here.</u>
- 2. Voting in NYC:
- a. In person at your assigned poll-site, during the <u>early voting period</u>, October 24th through November 1st, or on Election Day, November 3rd. Or by mailing your absentee ballot (with proper postage paid!) so it is postmarked by November 3rd. You can find <u>both your early voting and election day poll sites here</u>.
- b. For voting by absentee ballot: Request your <u>absentee ballot</u>, or <u>manage</u> your online <u>mail-in ballot</u> by visiting <u>Vote NYC</u> or calling 1-866-Vote-NYC (6-9-2). Keep in mind, the United States Postal Service issued guidance to voters across the country, "<u>as a common sense measure</u>" to mail your ballot before October 27th in New York.
- c. Join the #NYCDANCEUNITES campaign. Launched on October 2nd, five of New York City's acclaimed dance companies have joined together to create a new online initiative to urge the dance community to do their civic duty and vote. Learn more and download the campaign graphics for social media here.
- 3. NYC COVID-19 Updates:
- a. <u>Look up</u> your address to see if you live or work in a COVID-19 Hot Spot Zone where there are new restrictions. Maps of the cluster zones can be found <u>here</u>.
- b. New Mexico has been added to the State's COVID-19 Travel Advisory. See the full list  $\underline{\text{here}}$ .
  - c. Fines for sponsors of illicit mass gatherings increased to \$15,000
- d. Reminder to New Yorkers to get a flu shot. Find a flu vaccination site
- e. If you are experiencing COVID symptoms or believe you were exposed to someone who tested positive for COVID, get tested. <u>Find a testing site</u> near you.
- 4. Sign NYC Dance Studio Alliance petition  $\underline{\text{here}}$ . This petition is in support of the safe reopening of dance studios.
- 5. Engaging in a community action in support of dance workers? Submit to be listed on the #ArtistsAreNecessaryWorkers Campaign Activations page. Visit the page for events, actions, and platforms that are independently led by the NYC dance community.
- 6. Dance/NYC hosts weekly dance field-wide calls to address our questions, needs, and plans for the future as a field. Calls occur every Thursday, 4:00 pm. 5:00 p.m. Register!
