## NATIONAL

4. The Senate Health, Education, Labor, and Pensions (HELP) Committee has issued a request for stakeholder comments on workforce innovation to address lost jobs in the COVID-19 pandemic. This is an excellent opportunity for members of the Arts and Culture community to advocate for national economic recovery efforts. 5. The [Shuttered Venue Operators Grant \(SVOG\) formerly known as Save our Stages \(SOS\) program application process opens April 8](#). Here is [a sample template](#) that may be helpful with the application process.
6. President Biden announced [program changes](#) to make access to PPP loans more equitable and extended the program until May 31.

7. The Director of the Centers For Disease Control and Prevention (CDC) [signed an order to extend the eviction moratorium through June 30](#). At-risk tenants [must fill out this CDC form](#) and give it to their landlord (keep a copy for your records).

8. Take the Dance/USA Coronavirus Impact Survey part II This survey is designed to analyze the issues the dance sector has faced and are still facing as a result of the pandemic. It has been tailored for individuals working in dance (e.g., dancer, choreographer, independent arts professional, etc.) and organizational dancemakers (e.g., companies, collectives). The deadline to participate is Friday, April 9.

## NEW YORK STATE

1. The New York State arts and culture sector is asking for relief and support commensurate with the creative sector's impact on the state economy, and more importantly, with the role that it will play in leading the state's economic recovery. 2. [On April 2, event, arts, and entertainment venues were allowed to reopen at 33% capacity](#). Venues can host up to 100 people indoors or up to 200 people outdoors. If all attendees present proof of completed vaccination or recent negative test results prior to entry, capacity can increase up to 150 people indoors or up to 500 people outdoors. Social distancing, face coverings, health screening and other health protocols will be required by all attendees. [State interim guidance is available here](#).

3. New Yorkers For Culture and Arts are asking you to tell State legislators to save arts and culture so arts and culture can save our state and lead the recovery. Federal relief is finally headed to our city and states! State legislators are in the final days of budget negotiations. They need to provide the American Rescue Plan funds to the 'most impacted industries'---namely arts and culture! [Here is a toolkit to use](#)

Governor Cuomo and Legislators have agreed to [create a \\$10 million fund in the State budget to combat discrimination against Asian-Americans](#) in the wake of recent brutal assaults against the Asian-American community. Under the deal, \$10 million in grants will be distributed to community and social service groups to help address bias and curb crimes committed against Asian-Americans.

- All adults (over 16) in New York are eligible for the vaccine as of April 6. Find vaccination locations and make appointments online at [vaccinefinder.nyc.gov](#) or by calling 877-VAX4NYC for assistance in multiple languages. - The statewide positivity rate was 3.59%.
- Starting today, domestic travelers are no longer required to quarantine after entering New York from another U.S. State or U.S. Territory. While no longer required, the NYS Department of Health still recommends quarantine after domestic travel as an added precaution. Mandatory quarantine remains in effect for international travelers.
