# Weekly Advocacy Alert, April 14: A Moment for Grief and Solidarity

Dance/NYC holds space to mourn the death of Daunte Wright and to acknowledge the continuing violence against Black people at the hands of law enforcement caused by white supremacy. As a team of arts workers we seek to ensure the lives and vitality of Black people and Black culture as an ongoing commitment outside of and during crisis and to work in support of justice in New York City and beyond.

## Opening of the Broadway Vaccination Site for Arts And Cultural Workers



This week celebrated the opening of the <u>Broadway Vaccination Site</u> (aka ATC Vaccination Times Square) for arts and cultural workers. The site is now taking appointment requests <u>online</u> or by calling 877-829-4692. The vaccination site is working with <u>The Actors Fund</u> to aid individuals who need support with <u>making appointments</u>. ## NATIONAL

1. The Biden administration launched a funeral assistance program on Monday, April 12, those who lost loved ones to COVID-19 will be able to apply for retroactive reimbursements for burial costs. Applicants can receive up to \$9,000 per burial, *The Washington Post reports*. To apply, you must call 844-684-6333. The call center will be open from 9:00 a.m. to 9:00 p.m. ET, starting April 12.

2. Shuttered Venue Operators Grant (SVOG) program shutdown temporarily

with no specific date/time for relaunch. The <u>application user guide</u>, which was released and re-released just prior to the start of the program at 12:00PM(EST) on April 8. The SBA released the latest version of its <u>FAQ document (effective April 8)</u>. Here is <u>a sample template</u> that may be helpful with the application process.

- 3. President Biden signed the <u>PPP Extension Act, H.R. 1799</u>, giving nonprofits and other eligible borrowers until May 31 to submit their PPP applications. The Small Business Administration issued a <u>new interim final rule</u> revising the PPP rules to incorporate the American Rescue Plan Act's changes to the PPP.
  - PPP First Draw Borrower Application Form
  - PPP Second Draw Borrower Application Form
- 4. The <u>SBA announced</u> that it will increase the limit on Economic Injury Disaster Loan (EIDL) loans from \$150,000 to \$500,000.
- 5. The National Endowment for the Humanities (NEH) announced new funding opportunities to rapidly distribute American Rescue Plan Act funding to cultural organizations and educational institutions adversely affected by the coronavirus pandemic. These funding opportunities will provide direct grants to individual humanities institutions and grantmaking organizations to distribute as competitive subawards to affected organizations and individuals.

- 6. The Department of Health & Human Services announced that the special enrollment period that began on February 15 for <a href="HealthCare.gov">HealthCare.gov</a> will continue through August 15. This three-month extension allows people to enroll in or switch health plans with the credits that were included in the <a href="American Rescue Plan">American Rescue Plan</a>. People who received unemployment for at least one week this year are eligible for \$0 premium plans and the highest level of cost-sharing reductions.
- 7. The <u>Disability Policy Seminar</u> will be a virtual event from April 19- April 22. The seminar offers the opportunity for advocates, self-advocates, experts, and professionals in the field to come together and learn about key federal issues that affect them most

#### **NEW YORK STATE**

- 1. New York State budget <u>legislation passed</u> (\$212B, go to Budget tab). This includes:
  - 5% payment withholdings restored
  - \$2.1B for Excluded Workers
  - \$13M AAPI Emergency Fund
  - Fully funded Foundation Aid over next three years
  - 1% COLA for nonprofit OPWDD and OCFS workers
  - \$5B in additional revenue from tax reform
  - Full budget docs
- 2. The Department of Financial Services <u>will extend the emergency regulation</u> requiring all regulated health insurers to waive co-pays for the COVID-19 vaccine until April 30.
- 3. Nonprofit Westchester is holding a <u>budget forum</u> with Senate Majority Leader Stewart-Cousins on April 16.

- 4. Applications for affordable housing at <u>The Dorothy Ross Friedman</u>

Residence are now open. The Friedman is a supportive, shared housing (roommates) residence that offers affordable housing for working professionals in performing arts and entertainment, persons with HIV/AIDS, and senior citizens (60 years of age or older).

- 5. State Senator Liz Krueger hosts a virtual town hall, \*New York City: What Can We Do After Getting a COVID-19 Vaccination?" on April 15 at 7:00 p.m. NYU epidemiologist Dr. Celine Gounder will speak about reasonable post-vaccination activities, vaccine passports, and COVID workplace regulations. - 8. Dance/NYC hosts weekly dance field-wide calls. The call addresses questions, needs, and plans for the future of the field. Calls are Thursdays from 4:00 p.m. 5:00 p.m. <u>Be sure to register.</u>
- 9. For the ongoing <u>Coronavirus Dance Impact Study</u>, Dance/NYC is tracking studio & company temporary and permanent closures to gain a better understanding of the financial impact the pandemic is taking on the dance sector. This data will be used to better document this historic time and to be able to advocate for aid to policymakers.
