[Attend the Mayoral Forum on Culture and Arts on April 21 from 6:00 p.m. – 7:30 p.m.](#) This is coordinated by New Yorkers for Culture and Arts, Dance/NYC, and the Mayoral Host Committee. #### NATIONAL

1. [Shuttered Venue Operators Grant \(SVOG\)](#) program shutdown temporarily with no specific date/time for relaunch but the SBA has said it will hopefully open by the end of the week. The SBA released the latest version of its [FAQ document \(effective April 8\)](#). A new [application user guide](#) will be available at least 24 hours prior to the program's relaunch. Here is [a sample template](#) that may be helpful with the application process, applicants may continue to register for a new account. The SBA is encouraging applicants to reach out to [various resource partners](#) across the nation for assistance. Timely information is being provided on the [SBA Twitter account](#) and SBA will continue to update its SVOG webpage with additional updates and information.

2. More than 400 charitable nonprofits have signed onto a [statement expressing strong support](#) for "the bipartisan Universal Giving Pandemic Response and Recovery Act" (S. 618 and H.R. 1704). The statement explains, "this legislation will further incentivize all taxpayers to give to charity – regardless of their income or whether they itemize – helping to spur even more giving as communities continue to fight and recover from COVID-19 and its economic effects." 3. Over the past three weeks, the Biden Administration has released extensive plans for rebuilding the nation's infrastructure, paying for the rebuilding program, and spending priorities for fiscal year 2022. As previously reported, the President is proposing the [American Jobs Plan](#), that calls for spending \$2.3 trillion on infrastructure, job training, and much more. To pay for the Jobs Plan, the Treasury Department released a summary of the [Made in America Tax Plan](#), a proposal to raise \$2.5 trillion through corporate tax hikes, primarily by increasing the business tax rate from 21% to 28%. Contact your elected officials to make sure there is dedicated American Jobs Plan funding going to arts and culture workforce development.

4. President Biden signed the [PPP Extension Act, H.R. 1799](#), giving nonprofits and other eligible borrowers until May 31 to submit their PPP applications. The Small Business Administration issued [a new interim final rule](#) revising the PPP rules to incorporate the American Rescue Plan Act's changes to the PPP.

## NEW YORK STATE

1. Join YuLing Koh Hsu from Campaign for NY Health and Dancer Artists' National Collective on April 21 from 6:00 p.m. - 7:00 p.m. ET for a [Healthcare Storytelling workshop and recording session for NY Health Act advocacy actions](#).
  2. Apply to [New York Foundation for the Arts Rauschenberg Medical Emergency Grants](#). The program provides one-time grants of up to \$5,000 for recent unexpected medical, dental, and mental health emergencies experienced by artists in the past six months. Deadline is Monday, May 3 for emergencies occurring September 1, 2020 or later.
  3. Apply to [New York State Council on the Arts Regrant for Teaching Artists](#). This is a partnership between the Arts Ed program and the NYC Arts in Education Roundtable. Teaching Artists will receive grants to create asynchronous learning resources – a series of 4-5 video mini-lessons, or any other non-live format, targeted to any age group. Teaching artists will receive much-needed income and sharpen their skills for today's arts teaching landscape, and the resulting lessons will be available on the NYSCA and NYCAIER's websites, free for anyone to use.
