In the last few months, a group of NYC-based artists, activists, and academics have formed the Disability/Arts/NYC Task Force. DANT is forming around a unique moment for disability arts and artistry. We are witnessing bold and brilliant artwork across genres and disciplines that take up disability as a profound aesthetic and analytic value. And yet, there are profound and persistent obstacles that limit the possibilities for disabled artists and artistry. DANT is in the process of naming this unique moment and developing a movement for disability arts to thrive in New York City.

As part of this ongoing work, we are hosting a groundbreaking convening that will bring together disabled artists, members of the broader arts community, and representatives from some of NYC's city agencies. We will use the convening to strengthen the coalition of disabled artists and allies while also beginning to craft a disability/arts platform for future policies and practices in NYC.
